Ko wai ahau / Who am I?

My name is Sara Passmore and I am a Doctoral student in Public Policy at Te Herenga Waka—Victoria University of Wellington. This research project is work towards my PhD thesis.

He aha te whāinga mō tēnei rangahau / What is the aim of the project?

This project aims to understand the relationship between a government contract being awarded and changes in the pro-social behaviours of workers in community organisations delivering social services. For this study, pro-social behaviours are defined as the sorts of things you on behalf of others rather than for yourself, and for the benefit of your organisation. These might include staying late, helping colleagues, sharing information, but also things like hiding information, not following policies, or bending the rules.

Your organisation's participation will support this research as one of three case studies that identify any changes in behaviours that occur when a contract is awarded, how workers in organisations perceived these changes, and whether the changes can be attributed to government contracting arrangements.

Ka pēhea tō āwhina mai / How can you help?

You have been invited to participate because of your involvement with one of three community organisations that have consented to participate in a study about the effects of government contracts for delivering social services. If you agree to take part, I will interview you at your organisation's main location or office. I will ask you questions about pro-social behaviours at work before and after the government contract was in place. The interview will take around an hour. I will audio record the interview with your permission and write it up later. You can choose to not answer any question or stop the interview at any time, without giving a reason. You can withdraw from the study by contacting me at any time within a calendar month of the interview taking place. If you withdraw, the information you provide will be destroyed or returned to you.

Your principal/director/head has provided us with an assurance that your participation (or not) in this research, including withdrawal during the study, will not affect your relationship/employment with the organisation.

Ka ahatia ngā kōrero ka tukuna mai / What will happen to the information you give?

This research is confidential. This means that the researcher named below will be aware of your identity, but the research data will be combined, and your identity will not be revealed in any reports, presentations, or public documentation. However, you should be aware that in small projects your identity might be obvious to others. While confidentiality of the research data is guaranteed, confidentiality of participation is not guaranteed to participants.

Only my supervisors and I will read the notes or transcript of the interview. Identifiable information will be kept securely and destroyed by 09 November 2025. The interview transcripts, summaries and any recordings will be kept securely and destroyed on 30 June 2032.

The information from my research will be used in my PhD dissertation, and academic publications and conferences.

- be able to read any reports of this research by emailing the researcher to request a copy.
